GENERAL ORDINANCE NO. 10, 2023

BEING AN ORDINANCE AMENDING CHAPTER 8, ARTICLE 4, DIVISION V, SECTIONS 8-122, OF THE WABASH CITY CODE FOR THE CITY OF WABASH, INDIANA PROVIDING FOR THE REGULATION OF SPEED LIMITS WITHIN THE CITY OF WABASH

WHEREAS, the City of Wabash has adopted an ordinance for the regulation of speed upon certain streets within the limits of the City of Wabash; and

WHEREAS, the ordinance currently does not provide any specific speed limits within the Southpointe Subdivision found on the east side of State Road 13 south near the City's corporate limits; and

WHEREAS, state law provides that the speed limit in urban areas where there is no posted limit is 30 miles per hour; and

WHEREAS, Southpointe has no through streets, is a residential only neighborhood entirely comprised of small to medium sized homes with a large population of children; and

WHEREAS, the Wabash City Traffic Commission has considered what is an appropriate speed limit in the Southpointe Subdivision and determined that a 20 mile per hour speed limit is more appropriate for the type of streets and character of the Southpointe Subdivision;

NOW THEREFORE BE IT HEREBY ORDAINED that Chapter 8, Article 4, Section 8-122 d, setting 20 miles per hour as the posted speed on certain streets, be amended as follows:

SECTION 1. Chapter 8, Article 4, Division V, Section 8-122 d. is hereby amended to add after "Chestnut Street" and before "Courtland Avenue" the following new street: "Chrysler Avenue, in its entirety."

SECTION 2. Chapter 8, Article 4, Division V, Section 8-122 d. is hereby amended to add after "Jackson Street" and before "Lincoln Street" the following new street: "LaSalle Avenue, in its entirety."

SECTION 3. Chapter 8, Article 4, Division V, Section 8-122 d. is hereby amended to add after "Vermont Streett" the following new street: "Williams Drive, in its entirety" and then add after "Williams Drive" and before Lafontaine Avenue," add the following new street: "Yohe Drive, in its entirety."

SECTION 4. All prior ordinances or parts thereof inconsistent with any provision of this ordinance are hereby repealed.
