Wabash City Council,

Pursuant to Ind. Code Ann. § 36-7-3-12, we bring this petition on behalf of the Board of Trustees of the Wabash Christian Church located In Wabash, Indiana. We hereby petition the Wabash City Council to vacate the alleyway separating two properties owned by the Wabash Christian Church south of West Sinclair Street.

#### Circumstances of the Case:

The alley in question is primarily a grassy way and it is unimproved. The alleyway has become an impediment to the use of the Wabash Christian Church. The vacation of this alley would allow the library to use the unimproved alleyway in future plans for the lots adjacent.

<u>Lack of Use</u>. The City's legal interest in the property appears of record or is reflected on an applicable plat. There is no public use for this alley way.

<u>Public Safety</u>. The existence of the alley way does not contribute to the community's public safety in any way.


Urban Design. The continuation of the alley does not serve as a positive urban design element.

<u>Community Purpose</u>. The Petitioner is proposing to incorporate the vacated alleyway into the general use of the adjacent lots. Both adjacent lots are owned by the Wabash Christian Church.


