INSTRUCTIONS TO APPLY FOR A VARIANCE OR A SPECIAL EXCEPTION WITH THE BOARD OF ZONING APPEALS

1. File all completed paperwork and the \$35.00 filing fee with the City of Wabash Building Commissioner's office, 10 days prior to the BZA meeting.
2. The Notice of Public Hearing (second page of the application) is the form that needs to be filled out and a copy given to the Wabash Plain Dealer to be published as a legal ad, one time only, 10 days before the meeting date. This expense is the responsibility of the property owner.
3. Also, you must obtain the names of all property owners within 300 feet of the property of the requested Variance or Special Exception. This information can be obtained from the County Auditor's office, based on the scale they go by. (Wabash County Court House, 1 West Hill Street, Wabash, IN 46992 (260) 563-0661) Once you have obtained the information from the Auditor's office, list all the names on a separate piece of paper and attach to the "Affidavit of Mailing Notices to Adjacent Property Owners." Send each Property owner a copy of the Notice of Public Hearing, by first class postage prepaid mail, 10 days before the meeting, and have the post office date stamp your list of names. Attach the date stamped list to the original Affidavit of Mailing.
4. VERY IMPORTANT: Be sure to get a Plot Plan of your property from the Recorder's office showing where your lot is located. Also, you need to have a drawing of your project.
5. Again, all paperwork must be back in the office of the Building Inspector, 10 days before the scheduled meeting. The BZA meets the third Thursday of each month @ 6:30 p.m., City Hall, 202 South Wabash St., Wabash, IN 46992.
