The proposed acre was located in a developable area, but Grow Wabash County proposed alternative locations. NIPSCO has not responded to these proposed alternatives.

Zartman added that no action needs to be done but she wanted to inform the RDC of the pending conversations with NIPSCO.

Old Business:

Updated lease agreements for Wedcor land for cash rent

Zartman explained that updates were made for the cash rent contract for McKillip seeds to farm on the 77-acre parcel currently owned by the City of Wabash.
