This policy is effective immediately and written to mean that if there is anything in which the City is involved and you "like" or comment on that post, that is speech that must have the disclaimer attached. This will be enforced through the normal disciplinary policies of the City. Titus made a motion to approve the Wabash City Social Media Policy. Mayor Long seconded the motion. Motion carried. This will be a part of the personnel paperwork going forward.
