As the Enforcement Authority for the City of Wabash, Indiana, you are hereby advised of the following:

YOU ARE HEREBY NOTIFIED that your HOUSE located at <u>626 Columbus St.</u> Wabash, IN 46992, has/have been declared, by this office, to be unsafe requiring their removal.

The structure located on the property has been severely damaged by fire, resulting in significant compromise to its structural integrity, including potential failure of load-bearing elements, walls, and roof systems. The building, in its current condition, presents an immediate danger to the health and safety of the public due to the risk of collapse, unstable debris, and exposure to hazardous materials such as charred electrical systems, mold, and possible asbestos. As such, the property has been determined to meet the criteria of an unsafe building under applicable code.

IN THE EVENT THIS DETERMINATION OF UNSAFE BUILDING IS UPHELD at the above referenced hearing, the following actions may be taken in the event you fail to comply with this Order:

- 1. The City of Wabash may remove the unsafe building(s) and/or structure(s) through its own workforce or obtain public bids for the removal of the unsafe building(s) and/or structure(s);
- 2. The City of Wabash may file a lawsuit seeking an injunction requiring you to take the ordered actions;
- 3. Civil penalties may be imposed;
- 4. A suit for costs may be instituted.

The above referenced actions are not exclusive but are provided to briefly indicate what action(s) may be taken if this Order is not complied with.

In addition to the following, and in accordance with Indiana Code 36-7-9-27, **YOU ARE FURTHER NOTIFIED THAT:** 

- (A) A person who has been issued and has received notice of an order relative to unsafe premises and has not complied with that order:
  - (1) Must supply full information regarding the order to a person who takes or agrees to take a substantial property interest in the unsafe premises before transferring or agreeing to transfer that interest;
  - (2) Must, within five (5) days after transferring or agreeing to transfer a substantial property interest in the unsafe premises, supply the Enforcement Authority with written copies of:
    - (a) The full name, address and telephone number of the person taking a substantial property interest in the unsafe premises; and
    - (b) The legal instrument under which the transfer or agreement to transfer the substantial property interest is accomplished.
