
~ SUPPLEMENTAL AGREEMENT NO. 1 ~

This Supplemental Agreement is made and entered into on _____, 2025 by and between **USI CONSULTANTS, INC.** and **CITY OF WABASH** (hereinafter referred to as the LOCAL PUBLIC AGENCY or LPA). WHEREAS, **USI CONSULTANTS, INC.** (hereinafter referred to as CONSULTANT) has been selected to provide professional engineering services to the LOCAL PUBLIC AGENCY, for the project hereinafter described:

WHEREAS, in order to provide for completion of the services, it is necessary to amend and supplement the Contract dated Friday, August 8, 2025.

WHEREAS, in order to provide for completion of the services, it is necessary to amend and supplement the Contract in the amount of \$1,500.00.

NOW, THEREFORE, it is agreed by and between the parties that the following Sections are amended as follows:

1. **APPENDIX A - "SERVICES BY CONSULTANT" is revised to add the following:**
TASK 1:
 - v. Cass Street from US 24 to Canal Street
 - w. Canal Street from Cass St to SR 15
 - x. Market St from Cass St to SR 15
2. **APPENDIX D – "COMPENSATION" the total fee not to exceed is revised to read as follows:**
\$39,500.00 (\$38,000 original fee plus \$1,500 additional)
3. **APPENDIX D – "COMPENSATION" fee scheduled is revised to read as follows:**


A. ADA Transition Plan Update:	\$28,000.00 \$ 29,500.00
B. Title VI Implementation Plan	\$ 10,000.00


4. Except as herein modified, changed and supplemented, all terms of the original contract dated Friday, August 8, 2025 shall continue in full force and effect.
