Meeting Called to Order:

Meeting called to order on September 16, 2025 at 4:04 p.m. by Marilyn Custer-Mitchell.

Minutes:

Custer-Mitchell presented the minutes from the August 5, 2025 meeting, which were sent prior.

Doug Konkle made a motion to approve the minutes as presented and was duly seconded by Jim Reynolds. Motion passed unanimously.

Invoices

Invoices were included in the packet from the following entities:

- Douglas Lehman, P.C., for various legal fees
- John H. Stephens for the survey of a parcel of land that is expected to be put up for sale to be purchased by NIPSCO for a communications tower.

Reynolds made a motion to approve the invoices as presented and was duly seconded by John Burnsworth. Motion passed unanimously.

New Business:

- 55 W. Water Street, Wabash (Sposeep & Sons Building)
 - Indiana Landmarks Scope of Service Agreement & Indiana Landmarks Protective Covenants & Right of First Refusal

Doug Lehman confirmed that he reviewed the agreements and saw no issues with the documents provided by Indiana Landmarks. Paul Hayden from Indiana Landmarks confirmed work is underway to capture, transport and rehome the cats in the Sposeep Building. Hayden also stated plans to post "No Trespassing" signs to hopefully deter people who continue to feed the cats.

Hayden added that Lundquist Real Estate & Appraisals is posting the building on the MLS database on Indiana Landmark's behalf to help promote sales and attraction. Bob Lundquist noted the challenges of selling such a building but is glad to be of service to Indiana Landmarks. He recommended accepting offers from anyone who has both the vision and the funds to make it happen. Lundquist noted he also intended to share properties on some other platforms, such as LoopNet, to attract potential buyers that way.

Hayden asked about the possibility of bringing electricity to the building. Hayden is also collaborating with a class at Wabash High School to use the building as a class project on historic renovation.

Reynolds clarified that the City RDC will not deed the property over to Indiana Landmarks until a buyer is identified, which Tenille Zartman confirmed.

Custer-Mitchell confirmed that there will be stipulations related to the timeline and work plans for a buyer, which can be adjusted as needed based on the buyer's and project plans. However, there will be stipulations nonetheless to ensure that if the building is sold, it does not remain empty and unused.

Reynolds made a motion to accept the scope of service agreement, the protective covenants, and the right of first refusal as presented, and it was duly seconded by Burnsworth. Motion passed unanimously.
