# **MINUTES**

# **CITY CLAIMS & SEWAGE CLAIMS**

# **OLD BUSINESS**

Unsafe Building Updates:

- 1. 595 Gillen Avenue Code Enforcement Officer Silas Zartman reported that bid requests were sent to five excavation companies; two responses were received by the deadline. Earthworks' (Eric Bostwick) bid was \$6,150 plus tipping fees and the quote from Treska Brothers Excavating was \$17,105. The mayor mentioned that in the past the City has paid the tipping fees. Reynolds made a motion to take both bids under advisement to clarify the bids, to then accept the lowest and authorize Mr. Zartman to accept the bid. Titus seconded the motion. Motion carried.
- 2. Public Safety Donation Fund Agreement This is between the Community Foundation and the City, primarily for the fire department at this time. Chief Oswalt stated that the purpose is to provide support for the charitable activities of the Wabash City Fire Department with donations. Titus made a motion to approve the agreement. Mayor Long seconded the motion. Motion carried. Chief Oswalt thanked Melissa Ford of the Community Foundation for her help with this Agreement.

#### **NEW BUSINESS**

- 1. Special Event Application Brandt Memorial Ride September 28. Stacy was present to answer questions. Mayor Long made a motion to approve the application. Reynolds seconded the motion. Motion carried.
- 2. Special Event Application Wabash High School Homecoming Parade September 19. Natasha was present to answer questions and reported that the route of the parade is the same as in past years. Reynolds made a motion to approve the application. Titus seconded the motion. Motion carried.
- 3. Wastewater Write-Off Approvals Patty Meagher of the Wastewater Department requested the City to write off \$2,196.66 worth of sewage bills. These are the unpaid bills of deceased customers. Mayor Long made a motion to approve the write-offs. Reynolds seconded the motion. Motion carried.
