  - A. Minutes from the August 21, 2025, meeting.
- 2. New Business:
  - A. Near Zero Energy Homes, LLC. Dale & Buffie Dennis of 2212 Sohngen Ct. Hamilton, OH. Request to petition the board for a Variance to build 3 homes 2 on Washington St. and 1 at 400 Ash St. Lot #10, Lot #11, and Lot #14. They plan to build 2 duplexes and 1 single family home. The total size of the homes will be between 1300 1800 Sq. Ft. The required lot size for homes in an R-3 zoning is required to be 70' wide and 80' wide for duplex homes. Each lot is going to be 66' wide.
  - B. Jack Delauter of 643 Pike St. requests to petition the board for a Variance to build and 11' X 24' addition to his existing garage. He is unable to meet the required setback requirements and will be 1' off the unimproved alley.
  - C. Beter Burns of Burns Distributing Co., Inc. of 140 Green Dr. Avilla, IN. request to petition the Board for a Special Exception for the parcel #85-10-36-300-024.000-008 at the corner of Us 24 and SR 13 to build a gas station. The Zoning is General Business and requires a Special Exception for a Gas Station.
