## **GENERAL ORDINANCE NO. 14, 2025**

## BEING AN ORDINANCE AMENDING CHAPTER 8, ARTICLE 4, DIVISION V, SECTION 8-121, OF THE WABASH CITY CODE FOR THE CITY OF WABASH, INDIANA PROVIDING FOR THE REGULATION OF SPEED LIMITS WITHIN THE CITY OF WABASH

WHEREAS, the City of Wabash has adopted an ordinance for the regulation of speed upon certain streets within the limits of the City of Wabash; and

WHEREAS, the ordinance currently provides for speeds within school zones with a limit of 20 miles; and

**WHEREAS**, the high degree of traffic occurring at some times of the day when children are present in large numbers creates a dangerous condition for which a more restrictive speed would be more appropriate;

**NOW THEREFORE BE IT HEREBY ORDAINED** that Chapter 8, Article 4, Sections 8-121 concerning speed limits in school zones be amended as follows:

**SECTION 1.** Chapter 8, Article 4, Division V, Section 8-121 is hereby amended to add new subparagraphs c and d which read as follows:

c. The following established speed limit for traffic traveling in the following designated school zones, shall be twenty (20) miles per hour:

| Maple Street    | From Miami Street to Cass Street;           |
|-----------------|---|
| Sinclair Street | From Cass Street to Miami Street;           |
| Colerain Street | From Harrison Avenue to Indian Hills Street |

d. The following established speed limit for traffic traveling in the following designated school zones, shall be ten (10) miles per hour:

The east-west alley between Miami Street and Cass Street located between Maple Street and Sinclair Street.

**SECTION 2.** Chapter 8, Article 4, Division V, Section 8-121 is hereby amended to re-letter the former subparagraph c to paragraph e.

**SECTION 3.** All prior ordinances or parts thereof inconsistent with any provision of this ordinance are hereby repealed.
