GENERAL ORDINANCE NO. 15, 2025

BEING AN ORDINANCE AMENDING VARIOUS PROVISIONS OF THE WABASH CITY CODE FOR THE CITY OF WABASH, INDIANA

WHEREAS, the City of Wabash has adopted the Wabash City Code; and

WHEREAS, certain provisions of the Wabash City Code need updating to reflect the current operations of the City;

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Wabash, Indiana as follows:

SECTION 1.

- **a.** Chapter 2, Article 4, Division 1, Section 2-25, subparagraph b is amended by deleting the words "Mayor and Clerk-Treasurer's office" and replace them with the words "Mayor, Clerk Treasurer, Mayor's Executive Assistant, and Department Heads offices".
- **b.** Chapter 2, Article 4, Division 1, Section 2-25, subparagraph c is amended by deleting the words "clerk-treasurer and mayor" and replacing them with the words "Mayor, Clerk-Treasurer, Mayor's Executive Assistant, and Department Heads".
- **c.** Chapter 2, Article 4, Division 1, Section 2-25, subparagraphs e-k are amended by deleting the words "clerk-treasurer and mayor" wherever they appear together and replacing them with the words "Mayor, Clerk-Treasurer, Mayor's Executive Assistant, and Department Heads".
- **d.** Chapter 2, Article 4, Division 1, Section 2-25 is also amended by adding a new subparagraph 1 which reads as follows: "The term credit card as used in this Section 2-25 includes not only a card issued in conjunction with a major credit card network such as VISA, Master Card, etc. as examples, but also a card issued by any retailer whose use is limited to that retailer's sites.

SECTION 2. Chapter 2, Article 6, Section 2-108 is hereby amended by deleting subparagraph b in its entirety and replacing it with the following:

b. The board of aviation commissioners meets on the second Wednesday of each month at 3:30 P.M. in the conference room of the Wabash Municipal Airport Terminal.

SECTION 3. Chapter 3, Section 3-5 is amended by adding deleting subparagraphs i-k and replacing them with the following:

- i. "Public Questions and Comments.
- j. Reports from Liaison appointments.

SECTION 4. All prior ordinances of parts thereof inconsistent with any provision of this ordinance are hereby repealed.
