# • Riverfront District Alcohol Permit Application

Kyle and Aubrey Williams were in attendance regarding their permit application.

Zartman reminded the commissioners of the Riverfront District Permit process. The RDC can approve liquor permits for businesses within the district. She also noted that the permit follows their business. Doug Lehman added that this number does not affect the downtown area's quota, which limits how many alcohol permits can be in the area.

Kyle explained that their two storefronts on Canal and Miami will be turned into a social club to host various events, recreation, etc., that serves alcohol but is not a bar. It would allow for a more family-friendly atmosphere, especially for the 18+ crowd that often cannot get into downtown bars. The space will include dartboards, pool tables, golf simulators, etc.

The food and drink offerings will be more packaged and vendor-type items, canned beers and the like, rather than leaning into the bar aspects.

The space would be 18+ for general business hours, but children would be allowed inside for private parties. There are also opportunities to host family nights, allowing all ages into the business without a party reservation.

Yohe made a motion to approve the application as presented, and it was duly seconded by Custer-Mitchell. Motion passed unanimously.
