

## **COMMON COUNCIL**

**December 15, 2025**

**The Common Council of the City of Wabash met in the Council Chambers of the City Hall and held a council meeting on Monday, December 15, 2025, in a special session.**

**The first item on the agenda was a Public Hearing regarding a grant application for a \$750,000 award for Federal money to construct a building to accommodate a Level 2 Recovery housing facility in the City of Wabash. Sandra Tamez, Executive Director for Region 3A, spoke at length about the proposal. For this award, the City would be the applicant and Waypoint of Wabash would be the subrecipient. The City is offering matching money from the Opioid and CEDIT Funds. No one else spoke and the Public Hearing was closed.**

**The Council meeting was then called to order with Mayor Long presiding. The Pledge of Allegiance was given in unison. The roll was answered by 6 Council members: Mitzi Pilgrim, Bill Barrows, John Burnsworth, Bryan Dillon, Terry Brewer, and Charlie Coyne. Eric Schoening was absent.**

**The minutes of the meeting held December 8, 2025, were approved. Council Member Dillon made a motion to accept the minutes. Council Member Brewer seconded the motion. All present were in favor.**

### **OLD BUSINESS:**

**There was no old business.**

### **NEW BUSINESS:**

- 1. Resolution No. 19, 2025 - Indiana Office of Community and Rural Affairs Standard Sub-Recipient Agreement for CDBG-Funded Project. Dillon made a motion to approve the Sub-Recipient Agreement authorizing the application submission and local match commitment. Council Member Barrows seconded the motion. All present were in favor. Officials from Waypoint signed the paperwork as others from Waypoint spoke about the need and the current benefits offered by the local House.**
- 2. Resolution No. 18, 2025 – Transfer of General Fund money to Rainy Day Fund. This is for the Veregy solar project and is needed to complete the additional appropriation approved at the last Council meeting.**

**Council Member Burnsworth made a motion to approve Resolution No. 18, 2025. Brewer seconded the motion. All present were in favor.**
