STORMWATER BOARD MEETING MINUTES

TUESDAY, MAY 20, 2014

Members present were Scott Long, Brandon France

Board President Scott Long called the Stormwater Board meeting to order.

MINUTES

NEW BUSINESS

1. Steve Schlemmer- Owner of 409 W. Maple Street, Wabash, IN.
Mr. Schlemmer appeared before the Board relative to the effects of the last two big storms. The first one (last year) brought 6 feet of water into his basement through the sewer. He lost a furnace and almost lost the electrical box. Handicapped people were living in the house and they had to be moved out for 3 days. The last big rain (this year), water was blowing through the sewer; it was following the sewer line up. The pressure was so great that it was coming around the sewer line, into the house, and filtrating the flagstone foundation and the new furnace was almost lost. It was 9 hours before the sewer rescinded.

Scott indicated he had talked to Rick. (Rick Price did not attend the meeting. Bob Gray attended the meeting on behalf of the wastewater plant.) Scott asked if someone from the wastewater plan has

looked at it. Apparently, Rick lifted the manhole cover and stated it was full and nowhere to go. Scott indicated it's not separated yet it's combined and on the list. The wastewater plant would continue to look into the matter and get with Mr. Schlemmer.

2. Updates from Brandon France (IAWC)-

Two main replacements are completed in town. Harrison to Elmwood project finished with restoration. The water tank (on SR 15) has been painted and is back in service.

3. Updates from Bob Gray (Wastewater Department)-

MS4 in the works; projects moving and projects slated. Looked at a trash removal system; it's slated within the budget. It takes trash out of the system, rotating collector and removes it before it hits the plant. Unfortunately, we need grip removal too. Neither one was designed into the plant in '94; it was cost cutting back then and down the road 20 years, you wished you had. Everything seems to be going great.
