SPECIAL ORDINANCE #1.2024

VACATING AN ALLEYWAY NORTH OF HILL STREET IN THE CITY OF WABASH, INDIANA

WHEREAS, the Wabash Carnegie Public Library, by the attorney for the Board of Trustees, pursuant to Indiana Code §36-7-3-12, petitioned the Common Council of the City of Wabash, Indiana to vacate a public alley way running north-south for a half block on the Wabash Carnegie Public Library property within the City of Wabash, Indiana, to-wit:

Running north-south between OP Lot 174 and

OP West 2' Lot 172 and OP Lot 173.

WHEREAS, the Wabash Carnegie Public Library is the owner of all real estate contiguous and adjacent thereto and is interested therein;

WHEREAS, notice of the Petition and the public hearing thereon has been given as required by law; and

WHEREAS, there is only one (1) owner of land that abuts the property to be vacated:

Wabash Carnegie Public Library, 188 West Hill Street, Wabash IN 46992

NOW, THEREFORE, BE IT ORDAINED THAT;

(1) The following ½ block alley way, to-wit:

Running north-south between OP Lot 174 and

OP West 2' Lot 172 and OP Lot 173

Is hereby vacated and the fee simple thereof shall revert by operation of law and by this Special Ordinance to the Wabash Carnegie Public Library.

(2) The Clerk-Treasurer shall furnish a copy of this Ordinance to the County Recorder for recording and the County Auditor, all as required by Indiana Code §36-7-3-12.

BE IT FURTHER ORDAINED THAT this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
